Support and Care for Chronic Conditions and Cancer

- ✓ Asthma Diagnosis The insurance will now cover both allergy and asthma diagnostics. Asthma is a common condition, and with this addition we are strengthening our coverage and meeting customer demand.
- ✓ Improved Coverage for Skin Cancer Treatment The insurance will now also cover recurrence (relapse of skin cancer). We are seeing an increase in inquiries related to skin cancer, and according to the Skin Cancer Database, the number of patients has increased by 116% over a 9-year period.
- ✓ Personal Health Programs for Life During and After Cancer (Late Effects) These programs will now be covered, regardless of whether the additional Cancer Care coverage has been purchased.
- ✓ Expanded Personal Health Programs for Osteoporosis and Multiple Chronic Conditions Going forward, we will cover digital, interdisciplinary health programs for diabetes, COPD, high blood pressure, cardiovascular disease, obesity, as well as osteoporosis and multiple chronic conditions (two or more)

Support for Long-Term and Chronic Pain, and Counseling for Concussion

✓ Pain Education for Long-Term/Chronic Musculoskeletal Pain (Optional Add-on F) — Based on the latest knowledge about long-term and chronic pain, we now offer an educational program designed to help individuals understand their own pain and learn tools to manage it—supporting better well-being in daily life.

Parent Program

The Parent Program is an online digital course for parents, that strengthens parenting skills and coping strategies. The program is available to parents og their and follows the recommendations of the Well-being Commission. It focuses on enhancing key parenting skills such as communication, emotional regulation, and problem-solving strategies. Children may also be included in conversations if deemed relevant by the practitioner.

Improved Terms for Emergency Crisis Support

We now offer enhanced coverage in the event of a serious incident/accident/death, as well as witnessing a sudden serious incident/accident/death or similar situations, where coverage is no longer limited to colleagues or family members.

Expanded Geographic Coverage and Support for Expatriate Employees

The geographic coverage area will be expanded to include the Nordic region, the EU, and the UK (specialist care).
